Izola Bank p.l.c. First Half 2015 Results - Highlights

Review of Performance

- Profit before tax of €2,080,305 for the six months ended 30 June 2015 up €135,865 or 7 per cent, compared with €1,944,440 for the same period in 2014.
- Operating income of €3,110,223 for the six months ended 30 June 2015, up €444,688 or 17 per cent, compared with €2,665,535 for the same period in 2014.
- The Bank's cost-to-income ratio increased to 33 per cent for the six months ended 30 June 2015, compared to 27 per cent for the same period in 2014.
- Loans and advances to customers of €45.8 million at 30 June 2015, up €12.8 million or 39 per cent, compared with 31 December 2014.
- Customer deposits of €92.9 million at 30 June 2015, up €2 million, or 2.2 per cent, compared with 31 December 2014.
- Total assets of €154 million at 30 June 2015, up €5.9 million, or 4 per cent, compared with 31 December 2014.
- Earnings per share of €3.38 for the six months ended 30 June 2015 were 5.6% higher than the earnings per share for the same period in 2014 (€3.20).

Commentary

Izola Bank delivered a profit before tax for the six months ended 30 June 2014 of €2,080,305. This figure was higher than the same period last year, mainly driven by an increase in net interest income and higher capital gains derived from the Bank's treasury operations.

Despite the prevailing low interest rates and record low yields, the Bank still managed to increase its net interest income by 29 per cent compared to the same period last year. For the six months ended 30 June 2015, net interest income was €1,178,143 compared with €910,540 at 30 June 2014.

Net fee and commission income of €1,375,980 for the six months ended 30 June 2015 increased marginally by €16,817, or 1.2 per cent, compared with 30 June 2014.

Administrative expenses increased by 21% compared to the same period last year and this resulted in an increase in the Bank's cost-to-income ratio of 6 percentage points from 27 per cent for the period ended 30 June 2014 to 33 per cent for the period ended 30 June 2015.

During the first six months of 2015 the bank grew its loans and advances to customers by €12.8 million, or 39 per cent and its investments were reduced by €11.8 million, or 16.7 per cent, compared with 31 December 2014. The quality of the lending portfolio showed no sign of deterioration whilst liquidity and capital ratios remained substantially above regulatory requirements.

Basis of preparation

The condensed interim financial statements have been extracted from Izola Bank p.l.c.'s (the 'bank') unaudited management accounts for the six months period ended 30 June 2015. These condensed interim financial statements are being published in terms of Chapter 5 of the Listing Rules issued by the Listing Authority and in terms of the Prevention of Financial Markets Abuse Act, 2005.

The condensed interim financial statements have been prepared in accordance with accounting standards adopted for use in the EU for interim financial statements (adopted IAS 34, Interim Financial Reporting). They do not include all of the information required for full annual financial statements, and should be read in conjunction with the financial statements for the year ended 31 December 2014.

The accounting policies applied in these condensed interim financial statements are the same as those applied by the bank in its financial statements as at, and for the year ended, 31 December 2014.

As required by the adopted IAS 34, Interim Financial Reporting, these interim financial statements include comparative statements of financial position information at the previous financial year end and comparative income statements information for the comparable interim periods of the immediately preceding financial year.
